### ORDER

Whereas this Ministry vide Notification No. 15-39(49)/2019-20/Sr. C.-I dated 07.10.2020 had called proposals for Regional Resource and Training Centres (RRTCs) under Integrated Programme for Senior Citizens (IPSrC) [a scheme under Atal Vayo Abhyuday Yojana (AVYAY)].

2. And whereas all the proposals which have been recommended by the States/ UTs, and its Implementing Agencies are not receiving grant in aid under IPSrC have been considered by the Screening Committee by adopting following eligibility criteria:-


Sl. No.	Criteria	Weightage
1.	Organisation should have worked in Social Sector with the Community for atleast 3 years and shall have presence in the State where applied	50 %
2.	Infrastructure and Capacity to train field personnel in the field of Sr. Citizens	25 %
3.	Professionally qualified staff working for the organisation atleast for the last 3 years and are committed social workers	15 %
4.	Adequate Financial stability; Be able to operate RRTC for a Minimum of 6 months (Reflected either by the Corpus funds held in its name or in terms of bank deposits)	10 %

3. By considering all the eligible applications with the criteria mentioned above, the following organizations have been finalized as new RRTCs which secured minimum 50% marks:-
